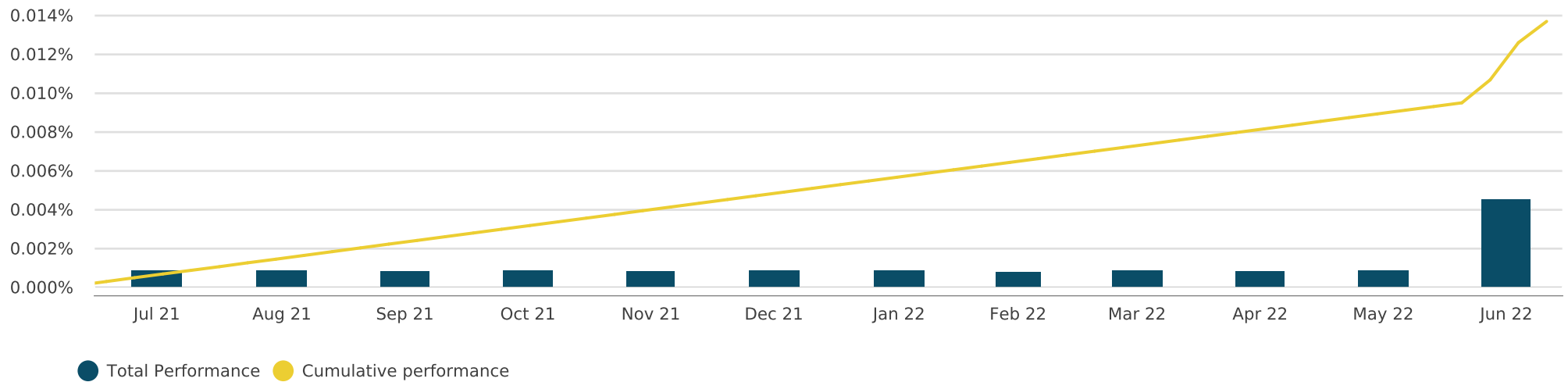

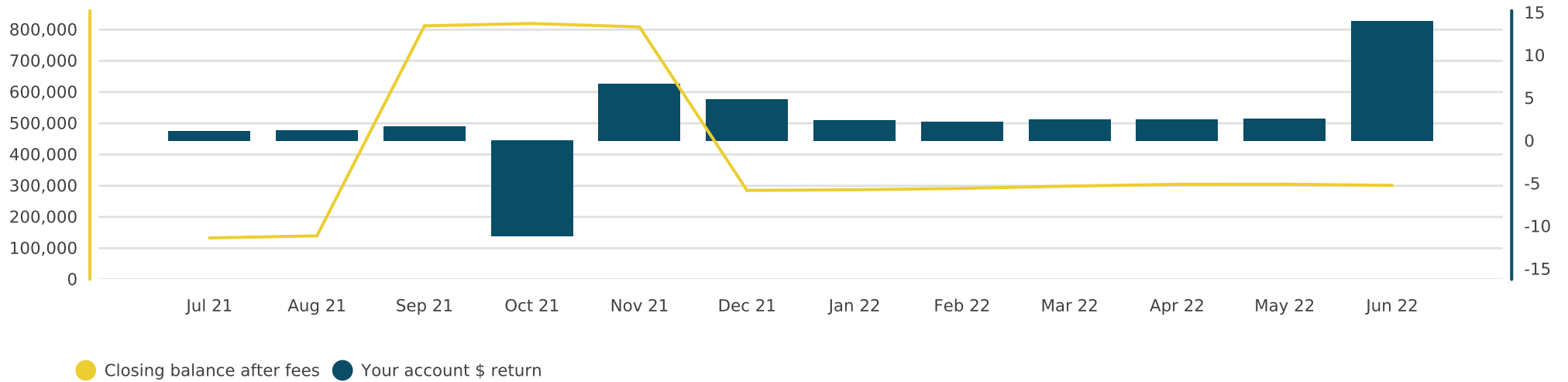

## Notes
