Part A: Financial report

I have audited the special purpose financial report of the THE COLE SUPERANNUATION FUND comprising the statement of financial position as at 30 June 2020, the operating statement, a summary of significant accounting policies and other explanatory notes' of the THE COLE SUPERANNUATION FUND for the year ended 30 June 2020.

In my opinion, the financial report presents fairly, in all material respects, in accordance with the accounting policies described in the notes to the financial statements, the financial position of the fund at 30 June 2020 and the results of its operations for the year then ended.

Basis for Opinion

My audit has been conducted in accordance with the Australian Auditing Standards. Emphasis of Matter - Basis of accounting
