The Commissioner of Taxation (the Commissioner) has the authority and responsibility for administering the legislation and enforcing trustees' compliance with the law.

- appoint an approved SMSF auditor each year, no later than 45 days before the due date for lodgment of the fund's annual return
- m lodge the fund's annual return, completed in its entirety, by the due date
- m review the independent audit report received from the approved SMSF auditor and take action as required notify the ATO within 28 days of any changes to the

 - membership of the fund, or trustees or directors of the corporate trustee
 - name of the fund
 - contact person and their contact details
 - postal address, registered address or address for service of notices for the fund
- notify the ATO in writing within 21 days if the fund becomes an Australian Prudential Regulation Authority (APRA) regulated fund.
