
The trustees declare that:

Specifically, the trustees declare that:


- in accordance with s120 of the Superannuation Industry (Supervision) Act 1993, no individual trustee has been or is a disqualified person;



MINUTES: The Chair reported that the minutes of the previous meeting had been signed as a true record.


TRUST DEED: The Chair tabled advice received from the Fund's legal adviser confirming that the fund's trust deed is consistent with all relevant superannuation and trust law.







We confirm we have no knowledge of any events or conditions that would cast significant doubt on the fund's ability to continue as a going concern.




