#### INTRODUCTION

- A. Pursuant to a Deed of Trust dated 21 September 2000 (Trust Deed) the Henry Vogel Pension Fund (Fund) was established.
- B. By Clause 6 of the Deed the Members have the power by resolution to remove the Trustee of the Fund and to appoint a new trustee in its place in the manner set out in that clause.
- C. The Members wish to remove the Old Trustee as trustee of the Fund and appoint the New Trustee in its place.
- D. The New Trustee has consented to act as trustee of the Fund.
- E. The Old trustee wishes to acknowledge that it has notice of its removal as trustee of the Fund and of the appointment of the New Trustee in its place.

### IT IS AGREED

- 1. The Members remove the Old Trustee as trustee of the Fund and appoint the New Trustee in its place.
- 2. The New Trustee accepts appointment as trustee of the Fund.
- 3. The Old Trustee acknowledges it has notice of its removal as trustee of the Fund and the appointment of the New Trustee in its place.
