- VALUATION METHODOLOGY:** The Trustee **NOTED** that each of the Entities is required to prepare annual financial statements and that these financial statements are independently audited and prepared on a fair value (market value) basis.
IT WAS RESOLVED that trustee use the audited annual accounts as a basis for determining market valuation to revalue the investments at the end of each financial year.
- INVESTMENT REGISTER:** The Trustee **NOTED** that the investment register of unlisted investments (as per Annexure 1) provides the Trustee’s determination of the market value of those investments.
