# 4. COVENANTS

In pursuance of the objects and for the purposes of carrying it into effect the Trustee convenants to perform and observe the provisions of this Deed and the Rules.

# 5. AMENDMENTS TO DEED

Any amendments to this Deed shall be made in the manner set forth in the Rules.
