FINANCIAL REPORT: The Superannuation Fund is not a reporting entity because in the trustee's opinion, there is unlikely to exist users who are unable to command the preparation of reports tailored so as to satisfy specifically all of their information needs. This is therefore a special purpose financial report that has been prepared for internal use only.

The special purpose financial report, trustee's resolution, auditor's report and member statements of the Superannuation Fund for the year were tabled.

RESOLVED that they be approved, adopted and signed by the trustees of the Superannuation Fund.

ANNUAL RETURN: Having considered the operation of the fund for the year, the trustee/s believes that the fund has satisfied the Superannuation Fund conditions and has met all the requirements of the Superannuation Industry (Supervision) Act 1993 and Regulations.

RESOLVED that the annual return be completed and signed by the trustee/s to indicate that the fund has complied with all the SIS requirements.

REVIEW OF OPERATIONS: The trustee/s tabled the operating results of the Superannuation Fund for consideration.

RESOLVED that the format of the members' statements and the trustees' annual report be approved being satisfied all matters required to be disclosed therein have been included.

RESOLVED that members' statements and the trustees' annual report be distributed to the members of the fund.

TRUSTEE STATUS: The trustee/s confirmed that they are qualified to act as a trustee of the fund and that they are not a disqualified person as defined by Section 121 of the SIS Act.

CLOSURE: There being no further business, the Chairman declared the meeting closed.
